1. 甲方需按照协议书，一共支付乙方 **6.000** 欧元。

Party A shall pay Party B a total of **EUR 6.000** in accordance with the Agreement

2. 甲方需在项目开始之前支付乙方 6.000 欧元（不含税）。乙方在收到此费用后立即为甲方所委托的项目进行操作。

Party A shall pay Party B € 6.000 (excluding tax) prior to the commencement of the project. Upon receipt of this fee, Party B will immediately carry out the operation for the project entrusted by Party A.

3. 如因甲方公司或申请人的自身原因导致项目停止或失败，乙方不予退还委托款。

If the project is stopped or fails due to Party A's company's or Applicant own reasons, Party B will not refund the Mandatory Fee.

4. 乙方如在办理期间无故联系不到甲方 30 个工作日内，导致严重影响项目进度，则甲方被视为自动放弃并终止办理所委托项目。在这种情况下，乙方不退还委托款，并且此委托款无法作为下一次委托乙方的费用使用。

If Party B is unable to contact Party A for more than 30 working days during the processing period for no apparent reason, resulting in serious disruption to the project schedule, Party A will be deemed to have automatically abandoned and terminated the project entrusted to it. In such a case, Party B will not refund the Mandatory Fee and the Mandatory Fee cannot be used as a fee for the next case.

5. 自乙方收到甲方合约款项之日起，根据申请人自身的条件，为其申请工作签证。此项目运作时间约为 3-4 月不等。乙方在所委托项目的办理期间，如遇特殊情况（如德国重大假期、政府工作人员休假等），乙方有权延长项目运作时间。

From the date Party B receives the contractual payment from Party A, it applies for a work visa for the Applicant, depending on Applicant's own conditions. The duration of this project varies from 3 to 4 months and Party B is entitled to extend the duration of the project in case of special circumstances (e.g. major holidays in Germany, government staff holidays, etc.) during the processing of the entrusted project.

This agreement will take effect when it is signed by both parties and Party A pays Party B the prescribed fees in accordance with the agreement within one month of the date of signature.

10. 适用法律及争议解决 Governing Law; Disputes

本协议适用并由中华人民共和国法律解释。因本协议产生的或与本协议有关的任何争议, 若不能够通过友好协商途径解决, 则应当通过中国国际经济贸易仲裁委员会仲裁规则并由一名仲裁员在北京仲裁解决。

This Agreement shall be governed by and interpreted in accordance with the laws of the People's Republic of China. Any dispute arising out of or relating to this Agreement shall be settled before a sole arbitrator in accordance with the Arbitration Rules of the China International Economic and Trade Arbitration Commission (CIETAC) in Beijing.
