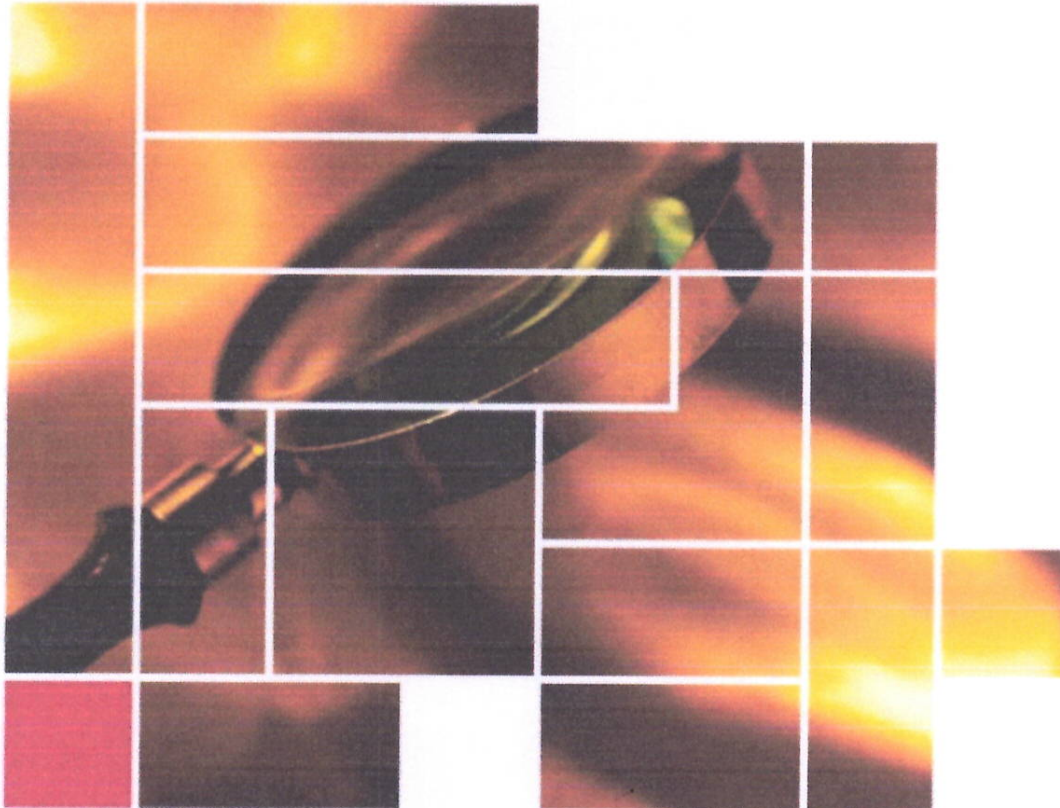

1. INTRODUCTION

This proposal outlines the process that SAI Global will adopt to assist Changchun Goldrare Automobile Parts Co., Ltd. to achieve certification in the IATF16949 program.

Sales, Contract Review, Product Design, Process design, Test, Supplier management are carried out at support site: Beijing Goldrare Automotive Parts Co., Ltd. at Liu Cun Town Industrial Park, Changping District, Beijing 102204 China

Application and Program Planning 申请与项目计划

An early application is advised to enable us to plan and adjust our service delivery process to best suit the needs and expectations of your organisation.

Upon application, you will be advised of the Client Manager who will be responsible for facilitating your Readiness Review and Certification Audit. STAGE 1 AUDIT: Readiness Review required for each manufacturing site

审核阶段 1：对每个制造现场的准备性评审

The Readiness Review will provide management and staff with the opportunity to discuss any problems and required improvements, and address other queries regarding the certification audit process. The auditor will review your management system reference documents describing how your business operates, to ensure that the documented management system meets the requirements of the IATF16949 program. This Review will essentially establish your system's state of readiness for the Stage 2 - Certification Audit and provide input to the planning process. 准备性评审中，公司管理层和员工可以讨论与认证审核过程有关的问题、改进机会。审核员将评审形成文件化的管理体系所描述的业务运作，判断其是否符合 IATF16949 的要求。这个过程将判断贵公司为进入第二阶段审核—认证审核的准备状态，并为策划过程提供输入

SAI Global's auditor will provide a report that will identify the readiness of your system to meet the requirements of IATF16949. Recommendations will be made regarding the next stage of the certification process. If you are considered not ready to progress to the stage two audit a subsequent readiness review will be required to again verify your readiness.

STAGE 2 AUDIT: Certification Audit and Registration

The Certification Audit is a detailed, full system assessment to verify that the requirements of IATF16949 and your customer specific requirements are fully implemented and effectively complied with.

Following a satisfactory audit by SAI Global, your company will be recommended for IATF16949 certification providing that all non-conformances have been cleared.

Certification Maintenance – Surveillance Audits

认证维持-监督审核

Once certification and registration are achieved, Surveillance Audits will be required to ensure that the system is being adequately maintained. Frequencies contained in this proposal will be confirmed by your Client Manager. Once the frequencies are confirmed they will be in place for the three (3) year life of the certificate.

Surveillance audits are a requirement of this program. Triennial Re-Certification Audit

Certification is valid for a period of three years and is renewable upon the conduct of a Re-certification Audit. The purpose of the recertification audit is to confirm the continued conformity and effectiveness of the management system as a whole and its continued relevance and applicability for the scope of certification.

One witness audit may include multiple physical locations of a client. 在 IATF 16949 审核期间，在某一地点和/或远程支持场所，开展见证审核，对 SAI Global 审核小组工作予以见证。某项见证审核可能包括某一客户的多个物理位置。
- OEM directed witness audits OEM 指定的见证审核
 - Witness audits requested by the OEM conducted at a site assigned by the OEM at their discretion (usually due to poor performance); The OEM representative can also be involved in this audit.
In both cases, the IATF witness auditor and the customer (OEM) representative shall not interfere with the audit. 在 OEM 自行指定地点开展 OEM 要求的见证审核（通常因绩效不佳所引起）；OEM 代表也可参与该审核。在两种情况下，IATF 见证审核人员和客户（OEM）代表均不得对该审核造成干扰。
- Office assessments 办公室评估
 - Conducted annually at SAI Global contracted office. The results from the office assessments may lead to additional assessments at the contracted office or other regional offices. 每年，在 SAI Global 的签约办公室实施评估。根据办公室评估结果，可在签约办公室或其它地区办公室处实施追加评估。
- Non- conformance management 不符合性管理
 - A non-conformity can be issued at either an office assessment, witness audit or as a special nonconformity due to performance related issue, complaint received from the IATF members or any violation of the Rules for achieving and maintaining IATF recognition. 根据办公室评估和见证审核，提出不符合性，或因绩效相关问题、IATF 成员投诉或违反实现和维持 IATF 认可规定引起的特定不符合性。
 - SAI Global has 90 days from the issue date of the non-conformance to implement a corrective action and verification of effective implementation for both major and minor non-conformity. If SAI global fails to submit the corrective action, the relevant IATF Oversight body (IAOB) shall initiate the de-recognition process. 自不符合性通知之日起 90 天内，SAI Global 可对主要和次要不符合性

采取改进措施，并对于实施效果予以验证。如 SAI Global 未能提交改进措施，相关 IATF 监督机构（IAOB）应启动取消认可程序。

In addition to the above-mentioned activities, SAIG's quality management system performance is measured through a number of process KPIs (key process indicators) designed for maintaining the integrity of the IATF database management such as: 除了上述活动外，可通过所设计的保持 IATF 数据库管理完整性的许多 KPIs（关键绩效指标）程序，对 SAIG 的质量管理体系绩效进行评测，比如

- Timeliness for Entry of Certificates (7 day metric) 证书输入及时性（7 天）
- Timeliness for Entry of Audits (20 days metric) 审核输入及时性（20 天）
- Timeliness for Issuance of Certificates (120 day metric) 证书发放及时性（120 天）
- Timeliness for Upload of Certificates (20 day metric) 证书上传及时性（20 天）

Finally, SAIG's performance is also measured for effectiveness and efficiency of the auditing process. The IATF Oversight body (IAOB) collects information on the following parameters: 最后，对 SAIG 的审计过程效果和效率进行评测。IATF 监督机构（IAOB）将收集下列参数信息：

- Number of audits with 0 non-conformances issued to the client 向客户发出的 0 条不符合审核数量
- Number of major/minor nonconformities raised per audit 每次审核发现的主要/次要不符合性数量
- Ratio of major nonconformities / number of nonconformities 主要不符合比例/不符合数量
- Ratio of major nonconformities (when witnessed) / number of nonconformities 主要不符合比例（见证情况下）/不符合数量

Although the auditing process indicators don't have a firm target and are calculated as a benchmark, year after year, the under-performing certification bodies are subject to rigorous systemic corrective actions addressing any signs of IATF auditor's soft-grading with the ultimate goal to improve the overall quality performance of the OEM supplier's base. 虽然审核过程指标未设立明确目标和进行标杆计算，但随着时间推移，绩效不佳的认证机构将面临更为严格的系统性改进措施，从而满足 IATF 审核人员的分级预期，以实现最终目标，由此提升 OEM 供应商的整体质量性能。
