

Annual Amendment 2024 to DISTRIBUTION AGREEMENT No. 06640-2014

This annual amendment 2024 (registered under n°2023-10906 and referred to as this "Amendment") is made as of November 24, 2023 by and between:

Dassault Systemes (Shanghai) Information Technology Co., Ltd., located at Unit 1701-04, F17, No.1366 Lujiazui Ring Road, China (Shanghai) Pilot Free Trade Zone, Shanghai, 200120, CHINA (hereinafter referred to as "3DS"),

And

BEIJING UNITED INFO TECHNOLOGY CO LTD, having its principal place of business located at ROOM 302 BUILDING B BEIJING, CULTURE CREATIVITY BUILDING NO 30, BEIYUAN ROAD CHAOYANG DISTRICT, BEIJING, BJ, 100107, CHINA (hereinafter referred to as "Distributor").

All capitalized terms used herein shall have the meaning ascribed to them in the Distribution Agreement (referred to as the "Agreement").

WHEREAS:

3DS and Distributor entered into a Distribution Agreement referenced No. 06640-2014, as amended from time to time, pursuant to which Distributor has accepted and agreed to act as a non-exclusive distributor of 3DS Group software products and/or services.

According to the terms of the Agreement, the purpose of this Amendment is to modify certain provisions of the Agreement as well as provide the applicable Incentives and Discounts Model Exhibit.

1. GENERAL TERMS

1.1 Section 3. Grant of Licenses

The parties acknowledge and agree that Section 3.2. "Licenses to Trademarks" is fully deleted and replaced by the following:

"Licenses to Trademarks. Subject to the terms and conditions of this Agreement and as set forth in the Distributor Licenses Exhibit for the duration of this Agreement, Distributor is granted and accepts, a non-exclusive, non-sub-licensable and non-transferable license to use (i) the Trademarks identifying the 3DS Offerings and (ii) the Trademarks identified as corporate in the Graphic Charter, solely in connection with the marketing and distribution of 3DS Offerings and Support Services in the Territory and in compliance with the conditions set forth in this Agreement and the Graphic Charter. Distributor shall not use or register marks (including within domain names or user IDs on the internet) confusingly similar to any Trademarks in connection with any goods or services. Distributor acknowledges that all rights in Trademarks and related domain names, company names, trade names, in registrations and application of registration thereof, and in all goodwill associated therewith, shall remain at all times the sole and exclusive property of the relevant 3DS Group Company. In the event of non-compliance, Distributor shall bear all costs and expenses incurred by 3DS Group Company to cease the infringement. Whenever Distributor uses Trademarks in any manner (including advertising, in all written and electronic communications, or other uses), Distributor shall clearly indicate that such Trademarks are owned by the relevant 3DS Group Company. In addition, Distributor's use of Trademarks on or in connection with any advertising,

9. EXPORT, ETHICS & COMPLIANCE

Distributor hereby confirms that the answers provided in the Ethics & Compliance questionnaire and the Declaration of Candidate signed by Distributor are still valid and commits, to promptly inform 3DS of any modification of its organization which may have an impact on the answers provided (i.e. modification in its shareholders, beneficial ownership, other relevant stakeholders, policies and training programs, nature of business and track records).

10. MISCELLANEOUS

The parties expressly agree that this Amendment shall enter into force on January 1st, 2024 and that all changes made by this Amendment shall apply to all Orders received by 3DS as of January 1st, 2024.

Except for the terms as modified herein, all other terms of the Agreement including its Exhibits remain unchanged, in full force and effect.

The parties agree to sign this Amendment electronically. Where electronic signature is not legally permitted by the governing law of the Agreement, it may be signed in two (2) counterparts, each of which will be considered as an original, but all of which together will constitute one and the same instrument.
