一、 申请内容/Contents of Application:

本次认证申请的详细信息见中国质量认证中心产品认证业务在线申办系统中填写的内容。/The details of this application is referenced in China Quality Certification Centre Product Certification Online System;

二、 认证委托人承诺/Commitment of the Applicant

本申请书项下认证委托人现就**本次认证**向CQC郑重承诺如下:

For the application for the certification, the applicant under this application hereby makes solemn commitment to CQC as follows:

1、保证认证对象^[1]具备相关法定资质、资格且未列入国家信用信息严重失信主体相关名录;保证认证对象等符合《产品质量法》《消费者权益保护法》《认证认可条例》《认证机构管理办法》等相关法律法规的规定,不得违背公序良俗,不得侵害他人的人身权利、财产权利以及其他合法权益,不得损害公共利益。

To ensure that the certification object has the corresponding statutory qualifications and has not been included in the relevant list of seriously dishonest entities concerning the national credit information; Ensure the certification object comply with relevant laws and regulations including but not limited to Product Quality Law of the People's Republic of China, Law of the People's Republic of China on the Protection of Rights and Interests of Consumers, Regulations of the People's Republic of China on Certification and Accreditation, Administrative Measures on Certification Bodies, and shall not violate the public order and good customs, harm the personal rights, property rights and other lawful rights and interests of others, nor harm public interests.

2、保证严格遵守法律、法规、部门规章和规范性文件的规定,以及认证所适用的认证规则(包括但不限于认证实施规则、技术要求等);根据相关法律法规,认证委托人、产品的生产者(制造商)或销售商应承担相应的主体责任,包括但不限于产品质量责任、侵权责任等。认证委托人知悉,CQC对申请认证产品作出合格评定,仅表明获证产品符合特定标准及认证规则要求,并不代表CQC将承担依法应由该等产品的生产者(制造商)或销售商承担的产品质量责任及其它任何法律责任。

To ensure the strict compliance with the provisions of laws, regulations, departmental rules and normative documents, as well as the applicable certification rules (including but not limited to the certification implementation rules, technical requirements, etc.); According to the relevant laws and regulations, the applicant, the producer (manufacturer) or the seller of the product shall bear the corresponding entity's responsibility, including but not limited to the product quality responsibility, tort liability, etc. The applicant is aware that CQC's conformity assessment of the products applying for certification only indicates that the certified products meet the requirements of specific standards and certification rules, and does not mean that CQC will bear the product quality responsibility and any other legal responsibility that should be borne by the producers (manufacturers) or sellers of such products according to law.

3、保证将向CQC提供其为进行本申请书项下认证活动所必需、真实、准确、完整、合法、有效的原始书面材料、副本材料、复印材料(包括电子文档)或口头说明,不存在任何虚假记载、误导性陈述或者重大遗漏之处,有关材料上的签字、印章真实、合法、有效,有关副本材料或复印件均与其正本材料或原件一致,作出的所有口头说明均与事实相符。

To ensure the original written materials, copy materials, duplicates (including electronic documents) or oral statements provided to CQC are necessary, true, accurate, complete, lawful and effective for the certification under this application, without any false records, misrepresentation or major omission, the signatures and seals on the relevant materials are true, legitimate and effective, and the relevant copy materials or duplicates are consistent with the reserved copy or the originals, and all the oral statements are consistent with the facts.

4、保证在认证过程和获证后始终遵守诚信，CQC在认证过程和获证后监督中做出的任何决定，均基于认证委托人诚信的前提。对于认证委托人实施欺诈、隐瞒、误导等不诚信行为造成的所有不利后果，CQC不承担任何责任。在申请认证产品的生产者（制造商）、授权代表、生产企业并非认证委托人的情况下，相关生产者（制造商）、授权代表、生产企业的失信行为视为认证委托人的失信行为。认证委托人自行承担任何因失信行为导致的法律责任。

To ensure that always comply with integrity in the process of certification and after being certified, any decision made by CQC in the process of certification and supervision after being certified is based on the premise of the applicant's integrity. CQC will not assume any responsibility for all adverse consequences caused by dishonest acts such as fraud, concealment and misleading by the applicant. Under the circumstances that the producer (manufacturer), the authorized representative or manufacturing enterprise applying for certification are not the applicant, the dishonest acts of the relevant producer (manufacturer), the authorized representative or manufacturing enterprise shall be regarded as dishonest acts of the applicant. Any legal liabilities caused by dishonest behavior shall be borne by the applicant.

5、认证委托人应当妥善保管在CQC网站“产品认证业务在线申办系统”^[2]申请的账号，包括用户名和密码，不得将该账号转让、出借、出租或分享予第三方使用，并应对以其账号进行的所有活动和事件负法律责任。

The applicant shall properly keep the account applied in CQC's website "online application system for product certification", including user name and password, and shall not transfer, lend, lease, or share the account to a third party for use, and shall be liable for all activities and events conducted with the use of the account.

6、本申请书记载的信息与认证委托人在CQC网站“产品认证业务在线申办系统”中提交的申请内容一致，详细信息以认证委托人在前述网页上填写并提交的具体内容为准；**认证委托人授权代理机构、中国办事处等代理人办理本次认证的，认证委托人知悉并认可，该代理人就本次认证向CQC作出的任何行为均视为认证委托人向CQC作出，且该等行为产生的全部法律效果直接归属于认证委托人。**

The information written in this application is consistent with the application content submitted by the applicant in the CQC's website "online application system for product certification", and the detailed information shall be subject to the specific content filled in and submitted by the applicant on the aforesaid webpage; **if the applicant authorizes an agency, China office or other agents to handle the certification, the applicant shall know and acknowledge that any act of the agent to CQC in respect of the certification shall be deemed to be done by the applicant to CQC, and all legal effects generated by such act shall be directly attributable to the certification applicant.**

7、保证本次认证所涉及的产品持续符合所适用的国家标准、行业标准及其它相关标准，并在该产品经过强制性产品自我声明并标注CCC标志后方可出厂、销售、进口或者在其他经营活动中使用，认证委托人对该等保证愿负法律上之责任。

To guarantee that the products involved in the certification conform to applicable national standards, industrial standards and other relevant standards, and that the products can only be delivered, sold, imported or used in other business activities after they have passed compulsory product self-declaration and labeled with CCC mark, and the applicant is willing to bear legal responsibility for such guarantees.

8、保证按时、足额支付本次认证所涉及的申请、试验、工厂检查及其它有关费用^[3]；如因认证委托人自身原因放弃、中止本次认证，或本次认证未获CQC通过的，认证委托人仍负有根据CQC已实际完成的工作向CQC支付相应费用的义务；在认证委托人未按照双方约定或CQC通知的期限足额支付有关认证费用达到【30】日时，认证委托人同意CQC享有随时暂停直至终止本次认证的权利。认证委托人知悉并理解，在认证流程的每一环节均存在认证不通过的可能性。

To ensure that paying the fees for the application, test, factory inspection and other related activities in the certification on time and in full amount; if the applicant abandons or suspends the certification due to his/her own reasons, or the application fails to pass CQC's certification, the applicant still has the obligation to pay the corresponding fees to CQC based on the work that CQC has actually completed; when the applicant fails to pay the relevant certification fees in full in accordance with the agreement or the time limit notified by CQC in 30 days, the applicant agrees that CQC has the right to suspend the certification at any time until termination of the certification. The applicant knows and understands that there is a possibility that the certification application may not pass at every step of the certification process.

9、在申请认证产品的生产者（制造商）、授权代表或生产企业并非认证委托人的情况下，认证委托人有义务促使相关生产者（制造商）、授权代表或生产企业履行相关义务，同意为本次认证之目的对生产者（制造商）、授权代表和生产企业的有关行为进行有效约束，协调其全力协助、配合CQC的认证工作，及时将CQC对生产者（制造商）/授权代表/生产企业的具体要求以书面形式告知生产者（制造商）/授权代表/生产企业，并要求生产者（制造商）/授权代表/生产企业就CQC对其工厂检查时发现的不符合项等及时反馈给认证委托人。

Under the circumstances that the producer (manufacturer), the authorized representative or manufacturing enterprise applying for certification are not the applicant, the applicant is liable for prompting the relevant producer (manufacturer), the authorized representative or manufacturing enterprise to perform their obligations, agrees to effectively restrict the relevant behaviors of the producer (manufacturer), the authorized representative and the manufacturing enterprise for the purpose of the certification, coordinate them to fully assist and cooperate with CQC's certification work, and timely inform the producer (manufacturer)/the authorized representative/the manufacturing enterprise of CQC's specific requirements for the producer (manufacturer)/the authorized representative/the manufacturing enterprise in written form. In addition, the producer (manufacturer)/the authorized representative/the manufacturing enterprise are required to timely give the feedbacks to the applicant on the nonconformities found by CQC in the factory inspection.

10、认证委托人将及时关注“产品认证业务在线申办系统”中的“通知”（包括不限于提交文件通知、送样通知、工厂检查通知、交费/费用结算通知）等与本次认证有关的信息。认证委托人保证其提供的样品的真实性及样品与实际生产的产品一致。认证委托人应当妥善保管型式试验报告、工厂检查报告和认证变更确认等与本次认证相关的资料，以备监督检查时使用。

The applicant shall timely pay attention to the “notice” (including but not limited to document submission notice, sample delivery notice, factory inspection notice, payment/expense settlement notice) and other information related to the certification on the “online application system for product certification”. The applicant shall ensure that the samples provided are consistent with the products actually being produced. Properly keep the type test report, factory inspection report and certification change confirmation and relevant materials related to the certification in case of supervision and inspection.

11、认证委托人、生产者（制造商）、授权代表和生产企业应当始终满足本次认证的要求，包括当收到CQC的通知时做出适当变更；如果本次认证适用于持续生产，则申请认证产品应持续满足认证要求。

The applicant, producer (manufacturer), the authorized representative and manufacturing enterprise shall always meet the requirements of the certification, including making appropriate changes when receiving the notice from CQC; If the certification is applicable to continuous production, the products applying for certification shall continuously meet the certification requirements.

12、当认证委托人、生产者（制造商）、授权代表和生产企业发生了以下任何一种可能影响满足认证要求的能力的变更时，包括不限于：法律地位、生产经营状况、组织机构或所有权或控股股东发生变更；法定代表人、主要的管理/决策或技术人员发生变更；对产品或生产工艺进行改进；联系地址或生产场地发生变化；质量管理体系出现重大变化等情形，认证委托人应在“产品认证业务在线申办系统”中提交变更申请。

When there is any change in relation to the applicant, producer (manufacturer), the authorized representative and manufacturing enterprise that may affect the ability to meet the certification requirements, including but not limited to the changes in the legal status, production and operation status, organization, ownership or controlling shareholder, changes in the legal representative, main management/decision-making or technical personnel; improvement of products or production processes, changes in contact address or production site, major changes of quality management system etc., the applicant shall submit the application for change on the “online application system for product certification”.

13、在本次认证实施过程中，当出现现场检查、书面审核、产品一致性检查等事项，认证委托人应当向CQC及其相关方做出所有必要的安排。

During the implementation of the certification, the applicant shall make all necessary arrangements to CQC and its related parties when there are on-site inspection, written audit, product consistency check, etc.

14、认证委托人有关认证的声明应与认证范围一致；**在使用认证结果对其获得II型自愿认证进行宣传时，认证委托人不得损害CQC的声誉，不得做出虚假广告或者误导性宣传或未经授权的有关产品认证的声明；**认证委托人确保不采用误导的方式使用或部分使用认证证书和报告；如果将认证文件的副本提供给其他人，文件应被完整地复制或者按照认证方案的规定复制。认证电子证书与纸质证书具有同等法律效力，认证委托人应妥善管理、规范使用电子证书。

The applicant's statement about certification shall be consistent with the certification scope; **When using the certification results to promote its type II CQC certification, the applicant shall not damage CQC's reputation, and shall not make any false advertisements, misleading publicity or unauthorized statement about product certification;** the applicant shall ensure that the certificate and report are not used in a wrong way or in part; if a copy of the certification document is provided to others, the documents shall be copied in full or in accordance with the provisions of the certification scheme. The electronic certificate has the same legal effect as the paper certificate. The applicant shall properly manage the use of the electronic certificate and make the use in a standardized way.

15、严格遵守与符合性标志的使用和产品相关信息的任何要求（包括不限于法律、法规、部门规章、规范性文件、认证规则及认证方案等），并承诺在提交自我声明后依据《强制性产品认证标志加施管理要求》^[4]加施认证标志。**鉴于II型自愿认证以生产者（制造商）或授权代表的CCC自我声明为最终表达方式的属性，不允许在产品主体及外包装上加施CQC标志。**

To strictly abide by any requirements related to the use of conformity marks and product related information (including but not limited to laws, regulations, departmental rules, normative documents, certification rules and certification schemes, etc.), and promise to affix certification marks in accordance with the Management Requirements for the Addition of Compulsory Product Certification Marks after submitting self-declaration. **In view of the attribute of type II CQC certification that the CCC self-declaration of the producer (manufacturer) or the authorized representative is the final expression, it is not allowed to add the CQC mark on the product body and outer packaging.**

16、**严禁伪造认证证书、认证标志。在文件、宣传册或广告等传播媒介中涉及到产品认证内容时，遵守CQC的要求或认证方案的规定；未获认证时，严禁使用CQC注册商标、商号进行任何宣传或广告。**

It is strictly prohibited to forge certificate, certification mark. When the content of product certification is involved in documents, brochures, advertisements and other media, the requirements of CQC or the regulations of certification scheme shall be followed; when certificate has not been granted, it is strictly prohibited to use CQC registered trademark or trade name for any publicity or advertisement.

17、认证委托人保证在申请本次认证之前六个月内，申请认证的产品不存在曾经被撤销自我声明的情形。若认证委托人、生产者（制造商）或生产厂出现重大投诉、重大舆情，经CQC评估认为相关获证产品可能会对人体健康或生命安全造成损害的，CQC可以暂停或撤销认证证书。认证证书被暂停期间或被撤销后，认证委托人应立即停止有关认证内容的广告和宣传，采取认证方案要求的措施（如交回认证文件）以及其他需要的措施。

The applicant guarantees that within six months before applying for the certification, the product applying for the certification has not ever been revoked self-declaration. If the applicant, producers (manufacturer) or manufacturing enterprise received major complaints or public opinions, CQC may suspend or withdrawn the certificate if it believes that the certified products may cause damage to human health or life safety after CQC's evaluation. During the period when the certificate is suspended or withdrawn, the applicant shall immediately stop the advertisement and publicity of the certification content, and take the measures required by the certification scheme (such as returning the certification documents) and other necessary measures.

18、保存已知的与认证要求符合性有关的所有投诉记录，以及对这些投诉和在产品中发现的影响认证要求符合性的任何缺陷所采取的适当的措施，并将所采取的措施形成文件，及时主动向CQC提供。

To keep records of all known complaints related to the conformity of certification requirements, and take appropriate measures for these complaints and any defects found in the products that affect the conformity of certification requirements, and document the measures taken and provide them to CQC in a timely and active manner.

19、认证委托人发现其获证产品在国家监督抽查、地方监督抽查或相关部门监督抽查中存在不合格的情形，或存在安全隐患，可能对人体健康和生命安全造成损害的，或生产者（制造商）、生产企业存在前述情形的，以及产品的生产者（制造商）或授权代表出现《强制性产品认证实施规则——自我声明》中规定的可能导致自我声明被撤销或实施整改的情形，无论其自我声明是否被认证监督管理部门撤销或采取其他处理措施，认证委托人均应在情况发生之日起5个工作日内以书面如实告知CQC，CQC根据实际情况，有权采取暂停、撤销证书以及其他必要措施。在需要时，要求认证委托人自行或由认证委托人督促产品的生产者（制造商）或授权代表及时向报送系统通报相关情况。

The applicant finds that the certified products are detected as unqualified in the national, local or relevant department's supervision and spot checks, or the certified products have potential safety hazards, which may cause damage to human health and life safety, or producers (manufacturer) or manufacturing enterprise has the aforesaid situation, and the producer (manufacturer) or the authorized representative of the product may cause the self-declaration to be revoked or implement rectification as specified in the "Implementation Rules on Compulsory Product Certification--self-declaration", regardless of whether the self-declaration is revoked by the certification supervision and management department or other measures are taken, the applicant shall inform CQC truthfully in writing within 5 working days from the date of occurrence, CQC has the right to suspend, withdraw the certificates and other necessary measures based on actual conditions. When necessary, the applicant is required to urge the producer (manufacturer) or the authorized representative of the product to report the relevant situation to the submission system in time or by the applicant.

20、认证委托人知悉，根据国家相关法律法规，当司法机关、行政主管部门、仲裁机构及其他相关部门依职权向CQC调查取证时，CQC有义务协助配合调查。认证委托人知悉并同意CQC会根据认证主管部门要求进行认证信息报送工作。

The applicant acknowledges that according to the relevant national laws and regulations, when the judicial authority, administrative department, arbitration body and other relevant departments investigate and collect evidence from CQC, CQC has the obligation to assist in the investigation. The applicant acknowledges and agrees that CQC will submit the certification information according to the requirements of relevant authorities.

21、认证委托人在申请书中填写的信息均是真实、准确、完整、有效、及时的，并且知悉一经CQC受理本次认证即表明同意受本申请书及受理通知书的约束。认证委托人确保在CQC留存的联系方式（包括不限于联系地址、联系人、电话、电子邮件等信息）的准确、有效，如联系方式发生任何变化应第一时间向CQC进行变更，否则认证委托人将承担因此而产生的一切不利后果（包括不限于认证决定、通知无法送达等）。

The information filled in by the applicant in the application is true, accurate, complete, effective and in time, and the applicant acknowledges that once CQC accepts the certification, the applicant agrees to be bound by the application and the acceptance notice. The applicant shall ensure that the contact information (including but not limited to contact address, contact person, telephone, e-mail and other information) retained in CQC is accurate and effective. In case of any changes of contact information, notice of change shall be sent to CQC as soon as possible, otherwise the applicant will bear all adverse consequences (including but not limited to the consequences of certification decision, notice cannot be delivered, etc.).

22、认证委托人已经仔细阅读并充分理解本申请书项下的全部内容，以及本申请所涉及或引用的相关法律法规、规范性文件、标准和要求；如违反本承诺，愿意承担由此引起的一切法律责任。CQC将根据具体情况要求认证委托人承担继续履行、采取补救措施、赔偿损失等违约责任，并保留暂停、撤销其认证证书的权利。

The applicant has read and fully understood all the contents of this application, as well as the relevant laws and regulations, normative documents, standards and requirements involved or quoted in this application. In case of any violation, the applicant is willing to bear all the legal responsibilities arising therefrom. CQC will require the applicant to bear the liability for breach of contract such as continuing to perform, taking remedial measures, compensating for losses, etc., and retain the right to suspend, withdraw the certificate.

The applicant shall timely and truthfully reply any question from CQC which is related to certification, and submit the required materials, other original documents or its duplicates to CQC in a timely manner.

24、认证委托人因认证事宜与CQC发生争议提起诉讼时，由CQC住所地人民法院管辖。

In case of a lawsuit regarding a dispute arising in certification between the applicant and CQC, the People's Court at the location of CQC's domicile shall have jurisdiction.

25、本文件由中英文版本书写，当英文版本与中文版本不一致时，以中文版本为准。

This document is written in Chinese and English. In case of any inconsistency between the English version and the Chinese version, the Chinese version shall prevail.

2、请用中文填写认证委托人、生产者（制造商）、生产企业和认证产品的名称，需要时请用中、英二种文字填写。

Please fill in the name of the applicant, producer (manufacturer), manufacturing enterprise and certified product in Chinese, or both in Chinese and English when necessary.

3、有关认证的公开文件可登录中国质量认证中心网站 (<http://www.cqc.com.cn>) 获取

The public documents related to CQC product certification can be obtained on the website of China Quality Certification Centre (<http://www.cqc.com.cn>).

4、如果申请II型自愿认证，同时也申请CB认证，请填写完“认证委托人承诺”后，继续填写CB认证申请书。

If applying for type II CQC certification and CB certification at the same time, please continue to fill in CB certification application after completing "Commitment of the Applicant".

5、II型自愿认证与CB认证同时申请时，生产者（制造商）必须相同。

When applying for type II CQC certification and CB certification at the same time, the producer (manufacturer) must be the same.

6、CB认证申请书以英文填写为准，相同的内容可以复制。

CB certification application shall be completed in English, and the same content can be copied.

7、经过认证的产品能够符合自我声明的技术要求，但本认证不是自我声明评价方式的替代，通过本认证后，制造商（生产者）或授权代表仍需在“强制性认证产品符合性自我声明信息报送系统”成功报送相关信息、提交自我声明后，方能按照相关规定加施CCC标志。制造商（生产者）或授权代表对其在报送系统中提交信息的过程、结果以及在后市场监管等环节的行为和因此导致的结果承担主体责任。

The certified products can meet the technical requirements of self-declaration, but the certification is not a substitute for self-declaration evaluation, after they have passed the certification, the manufacturer (producer) or the authorized representative still needs to enter the "information submission system for compulsory certification product conformity self-declaration" has successfully submitted the relevant information and submitted the self-declaration, the CCC mark can be added in accordance with relevant regulations. The manufacturer (producer) or the authorized representative shall bear the entity's responsibility for the process and results of submitting information in the submission system, as well as the actions in the post-market supervision and other links and the resulting results.

11、在证书到期前6个月，请关注证书状态及CQC“产品认证业务在线申办系统”的相关通知，并按照认证实施规则的规定申请“到期换证”。II型自愿认证证书到期前尚未按照要求完成到期换证的，会导致证书注销。

Please pay attention to the certificate status and the notice of CQC's "online application system for product certification" six months before the expiration of the certificate, and apply for "certificate renewal upon expiration" in accordance with the certification implementation rules. If the type II CQC certification renewal has not been completed before expiration, the certificate will be cancelled.

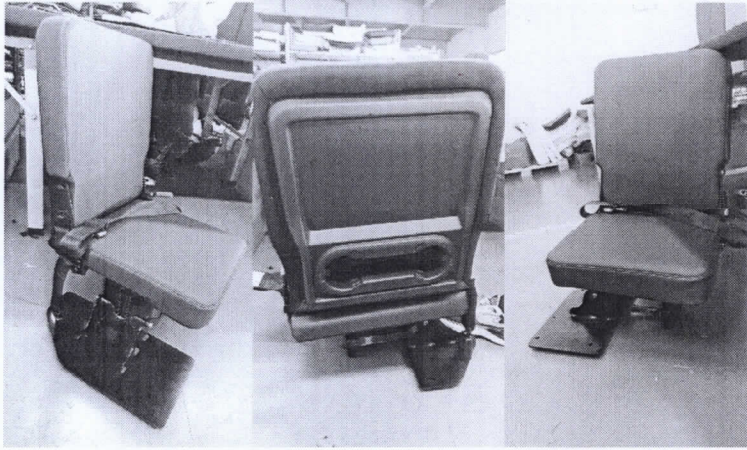

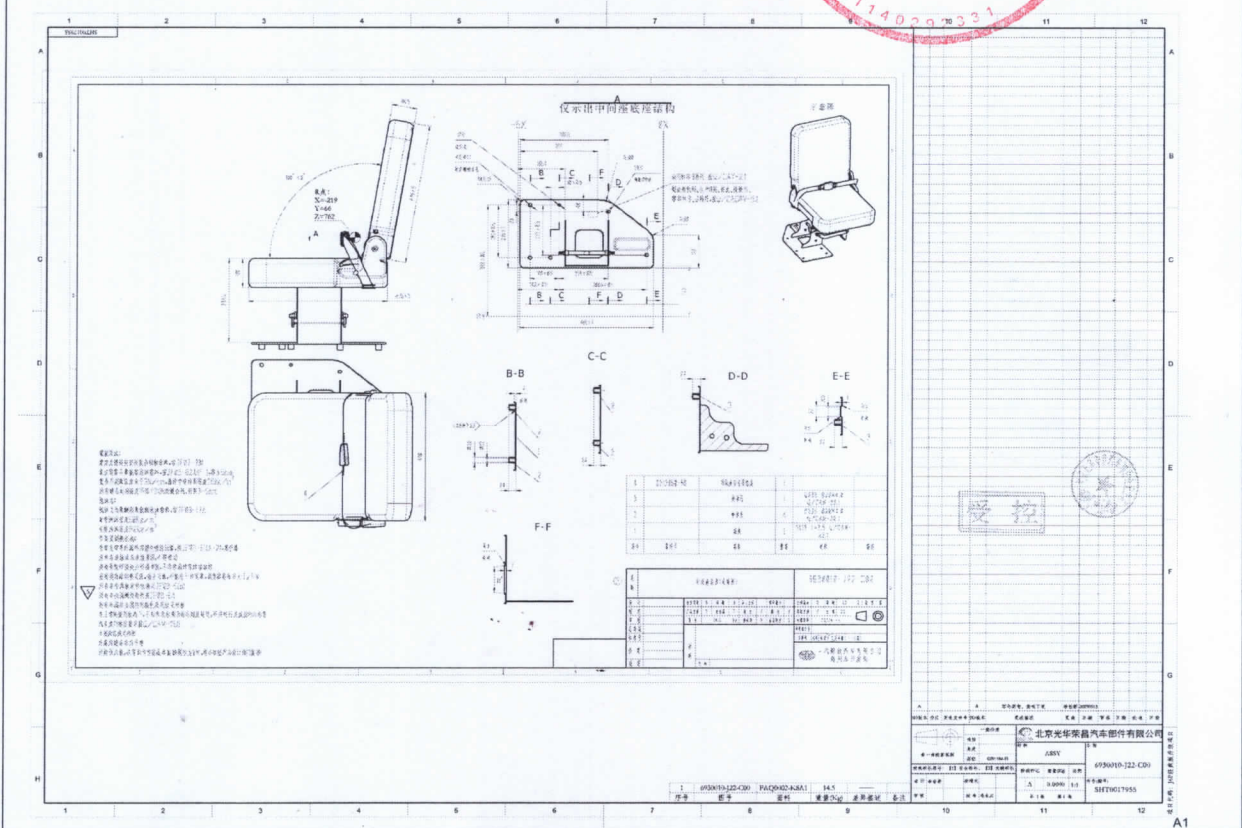
